Naikai), the first case of abuse of market dominance in China (Dexian v. Sony), a trademark infringement case published in SPC's Gazette (Lacoste v. Longhua), one of 50 typical IP cases in China for the year 2010 released by SPC (Abbott v. Yapei), an SEP case (Nokia v. Huaqin), an influential invention patent infringement case (Zhizhen v. Apple).
